I have grown up and spent a large part of my career in EMS here in Sweetwater County. During that period of time my colleague's and I have witnessed a very slow progression in the EMS community and Emergency Care in general, to the point where much of the community refuses to use our local ER and Hospital and would prefer to drive many miles to other facilities to seek medical attention. Since Dr. Prescott's arrival we have witnessed a good shift in the way the patients have been treated and the quality of care has increased along with community support.

With that being said there are individuals that don't understand that sometimes to create a good system that focuses on good quality patient care there needs to be a change in the way we practice, and when there is change there is always opposition. We currently have members on our hospital board that have no health care education and many times make decisions not based on health care but on personal opinions and agendas, this is where I believe our breakdown and problems originate. Not with Dr. Prescott.

I hope this letter helps to let you know at Pegasus and Jerry Klein, CEO of Memorial Hospital, that the EMS community stands fully behind Dr. Prescott and her decisions. Any individuals or groups that do not want Dr. Prescott to remain in her current position are ignorant to what it means to practice good medicine.
